To # Quit Claim Title to Real Estate.
 Eleanor L.Glover # The State of South Carolina. Whereas, I James S.Glover of the State
 of South Carolina, County of Colleton, did on the 31st day of August
 A.D. 1874, purchase at a tax sale made by George Washington as County Auditor for the County
 of Colleton & State aforesaid, under Acts of the general Assembly for said State approved
 March 2nd A.D. 1872, a tract of land hereinafter described by its boundaries for the sum of
 twenty two & 99/100 dollars and received titles therefor from the said Auditor of date
 August 31st 1874, which was duly entered in said Auditor's book of sales & conveyance on
 page 206 Sept. 14th 1874 and recorded in the Office of the R.M.C. for Colleton County in
 Book I p 275, as will appear by reference thereto, a tract of land in the County and State
 aforesaid described and bounded on the East by Edisto River, West by public road, South by
 L.C.Clifford & North by lands of Dr.F.Y.Glover. Know all men by these presents that I, James
 S.Glover of the Town of Walterboro, County & State aforesaid, in the State aforesaid, in con-
 sideration of the sum of twenty two & 99/100 dollars to me paid by Eleanor L.Glover in the
 State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and
 released, and by these presents do grant, bargain, sell and release unto the said Eleanor L.
 Glover:

All my right, title and interest in and to the tract of land above described as bounded on
 the East by the Edisto River, West by public road, South by lands of L.C.Clifford and North
 by lands of Dr.Francis Y.Glover, being the part of the West bank Plantation of the said F.Y.
 Glover and sold for taxes as aforesaid & purchased by me as aforesaid.
 Together with all and singular the rights, members, hereditaments and appurtenances to the
 said premises belonging or in anywise incident or appertaining. To have and to hold all and
 singular the said premises before mentioned unto the said Eleanor L.Glover, her heirs and
 assigns forever. And I do hereby bind my heirs, executors and administrators to warrant and
 forever defend all and singular the said premises unto the said Eleanor L.Glover, her heirs
 and assigns against myself and my heirs but against no others lawfully claiming or to claim
