On Friday, February 17, 2012 I was advised by Major Haase that on property on Camp Ave.

On Sunday, February 19, 2012 I was advised by Sgt. Wallact to meet Mr. Nettles between 10:00 and 10:30 AM in Jacksonboro in reference to the escort to Camp Ave.

On February 19, 2012 at approximately 10:12 AM, I met with Ted Nettles at the Sunoco station in Jacksonboro in reference to an escort. Mr. Nottles and his wife advised that they own 22 acres on Camp Ave. Ted stated that Sylvester "Scooter" Drew owns property across from theirs and put a gate across a county road to keep them from accessing their property. Ted stated that they are currently awaiting a court date for the case to be heard by a Circuti Court Judge. Ted showed me several maps from the State DOT and Colleton County showing that Camp Ave. extends beyond the gate that Mr. Drew put up. Ted stated that he wanted to go to his property and get his farm tractor. I advised Ted that until a judge determined if the road was a county road or private road he would haved to stay on the road. Ted agreed and I followed him to the property. I remained at the gate until Ted returned. As Ted was walking down the road, Mr. Drew arrived and asked me why I was allowing someone to trespass on his land. I advised Mr. Drew, who was obviously upset, that according to the several maps that I saw, the road appeared to be a county road and Mr. Nettles was going to his property to get a tractor. Mr. Drew requested my name and badge number which I provided to him, he then drove off.

I waited at the gate for Ted to return with his tractor and after about 30 mins he returned. As Ted was driving around the gate, the tractor attachment got caught on the gate and a piece of concrete next to the gate. Ted was unable to get the tractor free and requested the closest towing service to respond. As we waited for the tow truck to arrive, I noticed that Mr. Drew was parked just down the road.
